

Income Disclosure Statement

The income statistics below are for all United States Pruvit Ventures, Inc. (“Pruvit”) Promoters who were eligible to qualify for downline commissions in 2022. A “Promoter” is defined as having paid the \$49 annual Promoter fee at some point from January 2022 through December 2022. The average annual income for a Promoter in 2022 was \$2,392.51, and the median annual income for all Promoters in 2022 was \$10.59. 2.83% of all Promoters did not continue with Pruvit after their first year. Out of approximately 9,680 Promoters that signed up as U.S. Promoters since the beginning of 2022, approximately 9,406 were still active at the end of the year.

Promoter

In 2022, 44.15% (11,149) of Promoters qualified as an unranked Promoter. The average annual income of these Promoters, for 2022, was \$10.48, with a high of \$750.00 and a low of \$0. On average, unranked Promoters have been with Pruvit for 20 months.

Rank 1 (R1) Promoter

In 2022, 16.26% (4,106) of Promoters qualified as an R1 Promoter. The average annual income of these R1 Promoters, for 2022, was \$304.18, with a high of \$11,823.23 and a low of \$0. On average, R1 Promoters have been with Pruvit for 28 months.

Rank 2 (R2) Promoter

In 2022, 5.43% (1,371) of Promoters qualified as an R2 Promoter. The average annual income of these R2 Promoters, for 2022, was \$1,537.98, with a high of \$159,999.23 and a low of \$0. On average, R2 Promoters have been with Pruvit for 32 months.

Rank 3 (R3) Promoter

In 2022, .98% (247) of Promoters qualified as an R3 Promoter. The average annual income of these R3 Promoters, for 2022, was \$4,993.08, with a high of \$46,343.09 and a low of \$329.96. On average, R3 Promoters have been with Pruvit for 43 months.

Rank 4 (R4) Promoter

In 2022, 0.40% (101) of Promoters qualified as an R4 Promoter. The average annual income of these R4 Promoters, for 2022, was \$8,639.14, with a high of \$50,086.05 and a low of \$633.42. On average, R4 Promoters have been with Pruvit for 45 months.

Rank 5 (R5) Promoter

In 2022, 31.44% (7,939) of Promoters qualified as an R5 Promoter. The average annual income of these R5 Promoters, for 2022, was \$1,139.73, with a high of \$666,720.71 and a low of \$0. On average, R5 Promoters have been with Pruvit for 16 months.

Rank 6 (R6) Promoter

In 2022, 0.76% (191) of Promoters qualified as an R6 Promoter. The average annual income of these R6 Promoters, for 2022, was \$46,017.26, with a high of \$1,277,436.94 and a low of \$142.41. On average, R6 Promoters have been with Pruvit for 49 months.

Rank 7 (R7) Promoter

In 2022, 0.35% (88) of Promoters qualified as an R7 Promoter. The average annual income of these R7 Promoters, for 2022, was \$82,997.96 with a high of \$626,398.13 and a low of \$750.00. On average, R7 Promoters have been with Pruvit for 42 months.

Rank 8 (R8) Promoter

In 2022, 0.14% (35) of Promoters qualified as an R8 Promoter. The average annual income of these R8 Promoters, for 2022, was \$245,365.41, with a high of \$593,143.02 and a low of \$0. On average, R8 Promoters have been with Pruvit for 64 months.

Rank 9 (R9) Promoter

In 2022, 0.03% (7) of Promoters qualified as an R9 Promoter. The average annual income of these R9 Promoters, for 2022, was \$319,661.75, with a high of \$513,631.79 and a low of \$184,905.68. On average, R9 Promoters have been with Pruvit for 82 months.

Rank 10 (R10) Promoter

In 2022, 0.04% (10) of Promoters qualified as an R10 Promoter. The average annual income of these R10 Promoters, for 2022, was \$728,877.40, with a high of \$1,204,983.88 and a low of \$359,012.11. On average, R10 Promoters have been with Pruvit for 76 months.

Rank 11 (R11) Promoter

In 2022, 0.03% (7) of Promoters qualified as an R11 Promoter. The average annual income of these R11 Promoters, for 2022, was \$1,527,993.15, with a high of \$3,357,322.26 and a low of \$0. On average, R11 Promoters have been with Pruvit for 67 months.

Note that these figures do not represent a Pruvit Promoter's profit, as they do not consider profits earned from in-person retail sales or expenses incurred by a Promoter in operation or promotion of his/her business. The figures above refer to gross income (total income before any expenses are deducted). The expenses a Promoter incurs in the operation of his or her Pruvit business vary widely.
